**2009 – Concrete Rodeo Tour Events/Competitions  
Liability Release Waiver/Acknowledgement of Risk  
And Proof of Health Insurance**

The undersigned, my parent or legal guardian, if I am a minor, and I, in consideration of being allowed to participate in the Concrete Rodeo Tour competitions, and all related events and activities:

**I AGREE that I will** inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will immediately advise the Competition Director or other competition staff members of such condition(s) and refuse to participate. **I ACKNOWLEDGE and FULLY UNDERSTAND that I will be engaging in activities that involve risk of serious injury, including permanent disability and death**, and that severe social and economic losses might result not only from my own actions, inaction or negligence, but possibly from the actions, inaction or negligence of others, the rules of play or the condition of the premises or of any equipment used. Further, there may be other risks not known to me or not reasonably foreseeable at this time.

**I hereby assume all the risk** described above, even if Mainstream Marketing LLC, the applicable skatepark administration, applicable City and related associations, or its officers, directors, employees or agents, through negligence or otherwise, might otherwise be deemed liable. I hereby release, waive, discharge and covenant not to sue Mainstream Marketing LLC, the applicable Skatepark administration, applicable City and related associations, or its directors, officers, employees or any agents, coaches, participants, sponsoring agencies, sponsors, advertisers, or others associated with this event, and, if applicable, owners, leasers, or lessees, of premises used to conduct the skateboard events, from any and all liability arising out of my participation in the skateboard competition and/or event, even if the liability arises out of negligence that may not be foreseeable at this time.
